

Erasmus Mundus Joint Masters scholarships

INTAKE 2025. Pending of approval by the EU-CONEXUS
Academic Council.

Erasmus Mundus Joint Masters are high-level and integrated Master study programmes, designed and delivered by an international partnership of higher education institutions (HEI).

By supporting these jointly recognized master's degrees, the European Union aims at fostering excellence and internationalization of the participating institutions. There are also scholarships for students to take part in these prestigious programmes; the master's themselves offer them to the **best-ranked applicants worldwide**.

EU-CONEXUS joint Master programme in Marine Biotechnology has been selected by the Erasmus+ programme Erasmus Mundus Joint Masters (2022-2027, [Project No. 101050597 – JPMB](#)) and will be able to offer **around 20 scholarships yearly** to the best applicants in 2022, 2023, 2024, 2025.

What is Erasmus Mundus Joint Masters scholarship

The scholarship is awarded for full-time enrolment and will cover the entire duration of the Master programme (i.e., from the day of the start of studies until graduation, approx. 22 months). A reduced duration of the scholarship is applicable in case of recognition of prior learning (with a minimum scholarship duration of one academic year).

The monthly scholarship is 1400 EUR. The scholarship will be a contribution to the costs incurred by the beneficiary students and shall cover students' participation in the programme (i.e., the student does not pay any tuition fees), travel, visa and living cost.

The scholarship will be paid to the student to his/her bank account, preferably, opened in the first location of the programme (Spain) monthly.

Additional financial support to the individual needs of students with disabilities can be provided.

Eligible Erasmus Mundus scholarships holders

EMJM scholarships can be offered to students from all over the world. The candidate for Erasmus Mundus scholarship must meet all requirements to study joint master programme in Marine Biotechnology.

Students who have previously obtained an EMJM scholarship are not eligible to apply for an additional scholarship under the EMJM.

It is required that Erasmus Mundus scholarship holder studies in at least 2 EU-CONEXUS universities which are different from the country of residence at the moment of enrolment (signing the student agreement).

Special needs

Additional funding is available for participants with physical, mental or health-related conditions via the Erasmus Mundus special needs support. This additional support grant is a contribution based on real costs.

Selection

Erasmus Mundus scholarships will be offered to the best candidates following the selection procedure. The applications to start studies in September 2025 shall be submitted until **31/01/2025**. Read JMPMB Admission procedure and apply now!

It is foreseen to offer around **20 scholarships yearly** for the entire period of the study programme.

EU-CONEXUS Erasmus Mundus Joint Masters project requires to ensure geographical balance – i.e. no more than 10% of the total number of scholarships awarded during project implementation should be awarded to candidates from the same nationality (this rule does not apply to top up scholarships for targeted regions of the world, if applicable).
