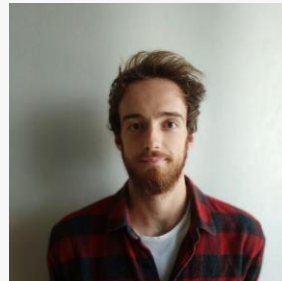

- 2) Promote non-formal and informal learning mobility and active participation among young people, as well as cooperation, quality, inclusion, creativity and innovation at the level of organisations and policies in the field of **youth**
- 3) Promote learning mobility of **sport** staff, as well as cooperation, quality, inclusion, creativity and innovation at the level of sport organisations and sport policies



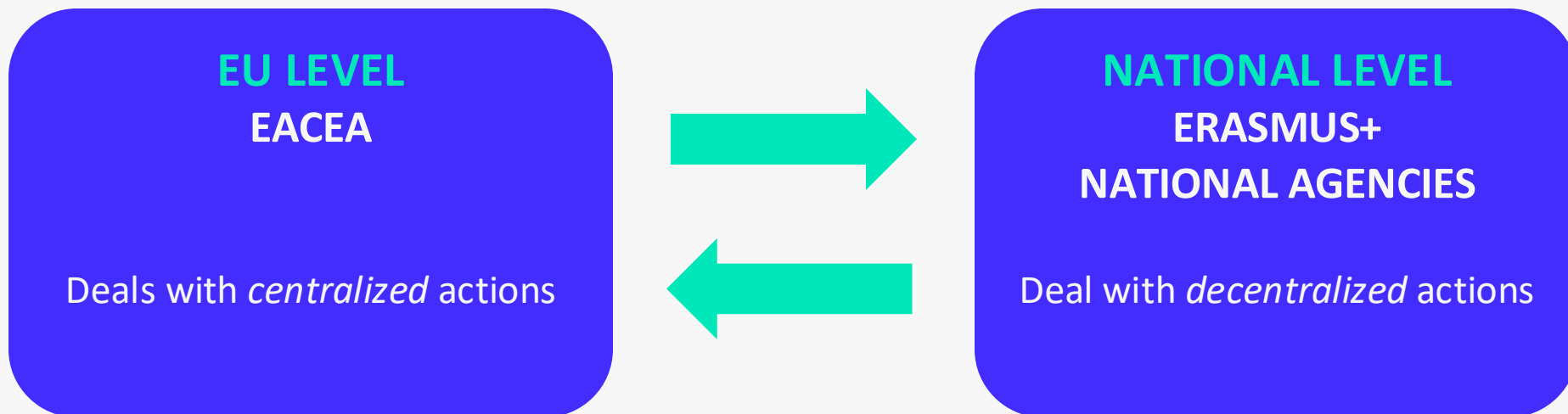

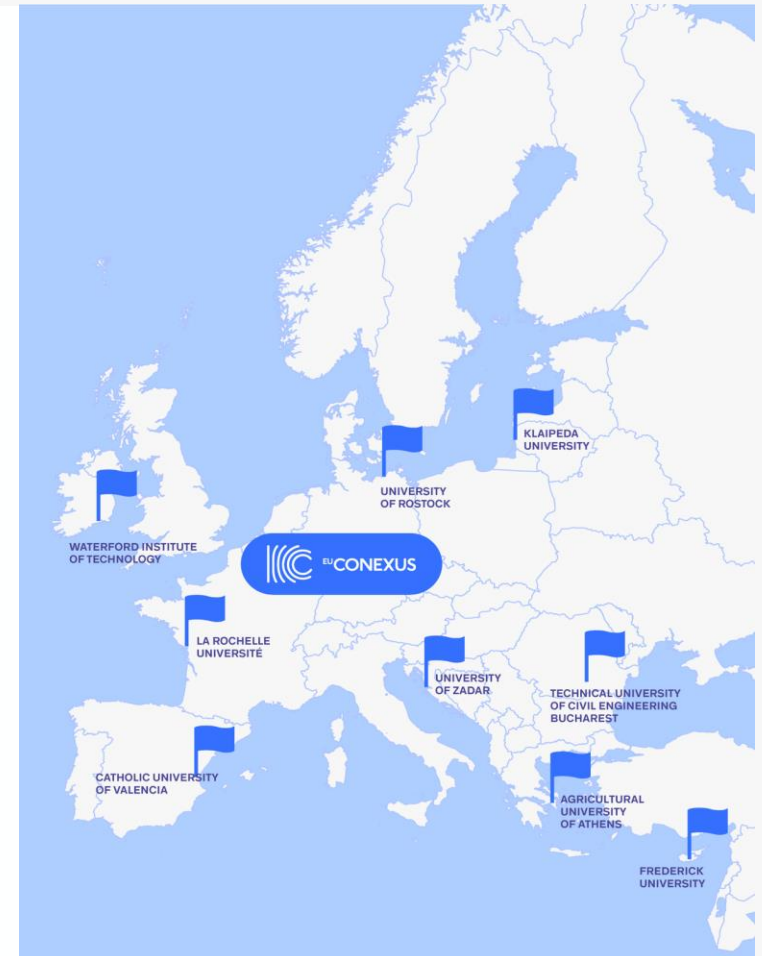

The single lump sum is a contribution to all costs related to the implementation of eligible activities:

- project management,
- learning, teaching and training activities,
- meetings and events,
- deliverables



# KA2 Small Scale Partnerships:

## OBJECTIVES OF THE ACTION

- Attract and widen access for newcomers, less experienced organisations and small-scale actors to the programme.
- Support the inclusion of target groups with fewer opportunities
- Support active European citizenship and bring the European dimension to the local level

Fixed lump sums available:

| **€30,000** or **€60,000** (These amounts cover all project-related costs, including management, implementation, and dissemination.)

## Application Deadlines:

**Round 1:** 5 March 2025

For projects starting between **1 September and 31 December 2025.**

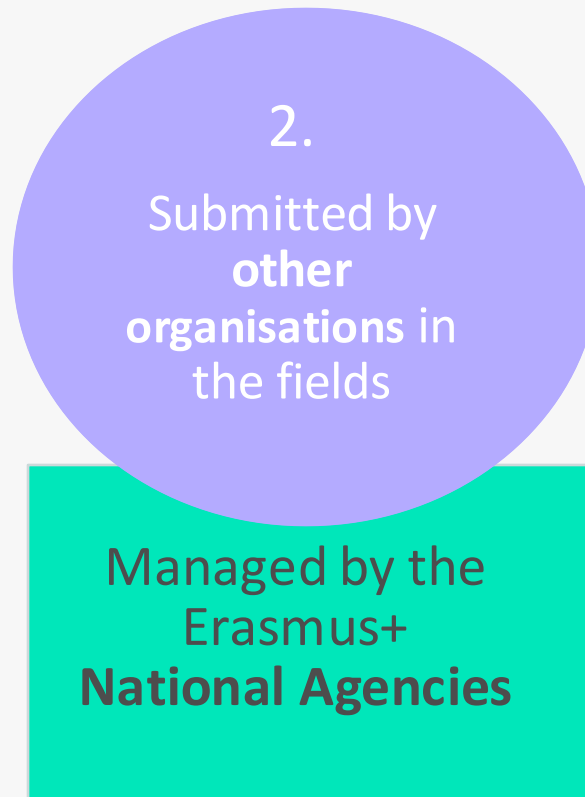
**Round 2:** 1 October 2025

For projects starting between **1 January and 31 August 2026.**



# Cooperation Partnerships

Depending on the applicant coordinator, there are two types of Cooperation Partnerships in the fields of education and training, and youth:



**Cooperation Partnerships** are open to organizations from education, training, youth, sport, socio-economic sectors, and those with cross-cutting activities (e.g., authorities, chambers of commerce, cultural and sport organizations). **Projects should involve diverse partners to leverage their expertise and deliver high-quality, relevant results.**



## Horizontal Priorities and Specific Objectives



### To Apply, You Must:

Address **at least one Horizontal Priority**.

Demonstrate alignment with **at least one Specific Objectives** for Higher Education.



For applications submitted to National Agencies in the fields of school education, vocational education and training, adult education and youth, the same organisation (one OID) cannot be involved in more than 10 applications (large scale) or 5 applications (small scale) overall per deadline, either as applicant or partner



# Approaching KA2 Cooperation Projects - Tips

## Identify Needs:

Assess specific challenges and opportunities within your educational programmes or cooperation activities.

Align these needs with your institution's strategic priorities.

## Align with Programme Objectives and Priorities:

Address key Erasmus+ objectives, such as innovation, inclusion, sustainability, and digital transformation.

Consider the **horizontal priorities**:

- **Inclusion and Diversity:** Foster equal opportunities and access.
- **Digital Transformation:** Enhance education through digital innovation.
- **Sustainability:** Contribute to environmental goals and green skills development.
- **Active Citizenship:** Promote civic engagement and EU values.

## Consider Policy Impact:

Demonstrate how your project will contribute to **national priorities** and **European policies**.

Focus on impacts such as employability, social inclusion, and education system modernization.

Strengthen Europe's innovation capacity.

## **Focus Areas:**

- Addressing skills mismatches.
- Focus on innovation, sustainability, and digital transformation.
- Enhancing cooperation between education, training, and businesses.

## **Divided into two lots:**

- Alliances for Education and Enterprises.
- Alliances for Sectoral Cooperation on Skills (implementing the 'Blueprint').



## Lot 1 Alliances for Education and Enterprises

- Boost innovation in education and training through collaboration with enterprises.
- Foster the development of entrepreneurial skills and mindsets.
- Enhance practical, work-based learning opportunities.

### **Activities Supported:**

- Development of new learning and teaching methods, including digital tools.
- Design and delivery of continuous education programs in partnership with enterprises.
- Creation of apprenticeship schemes and other work-based learning opportunities.
- Promotion of knowledge exchange between education institutions and businesses.

Institutional academic cooperation to showcase European excellence in higher education

Mobility for all students taking part, with EU-funded scholarships for the best students applying

Projects to improve HE institutions and their systems

- **Multilateral cooperation** between Erasmus and third-country institutions
- With activities and outcomes beneficial to **HE Institutions** and **Systems** of third-country



# Overview of KA2 Capacity Building in HE

Strengthen higher education institutions (HEIs) in partner countries by enhancing their quality, accessibility, and modernization.

## Key Goals:

- Foster cooperation between Erasmus+ Program countries and third countries.
- Address challenges in education systems, such as governance, inclusivity, and employability.
- Promote EU values through people-to-people contacts and intercultural dialogue.

## Types of Projects:

- **Fostering Access:** Improve opportunities for participation in HE.
- **Partnerships for Transformation:** Modernise HE systems and align them with labor market needs.
- **Structural Reform:** Support systemic changes and policy development.





# Funding, Activities, and Impact

## **Funding:**

- Fostering Access: €200,000–€400,000 (24–36 months).
- Partnerships for Transformation: €400,000–€800,000 (24–36 months).
- Structural Reform: €800,000–€1 million (36–48 months).

## **Activities Supported:**

- Development of new curricula and educational programs.
- Capacity building in governance and management of HEIs.
- Establishing international partnerships and regional cooperation.

## **Expected Impact**

- Modernized and internationally connected HEIs.
- Improved employability of graduates and alignment with labor market needs.
- Strengthened collaboration between HEIs and stakeholders, fostering inclusion and innovation.



# KA2 Not-for-Profit European Sport Events



# Not-for-Profit European Sport Events

Support the organisation of sport events with a European dimension, focusing on:

- Volunteering in sport.
- Social inclusion and combating discrimination, including gender equality.
- Encouraging healthy lifestyles through physical activity.
- Promoting traditional sports and games.
- Implementation of initiatives like HealthyLifestyle4All and EU Physical Activity Guidelines.

## **Key Activities Supported:**

- Preparation and organisation of events.
- Educational activities for athletes, coaches, and volunteers.
- Side activities such as conferences or seminars.
- Training volunteers.
- Legacy activities like evaluations and future planning.
- Communication and awareness-raising related to the event.



# Funding, Dates and Application

## Funding

- **Type I European Local Events:**
  - Grant: **€200,000**.
  - Minimum of **three organisations** from **three different eligible countries**.
- **Type II European Local Events:**
  - Grant: **€300,000**.
  - Minimum of **six organisations** from **six different eligible countries**.
- **European-Wide Events:**
  - Grant: **€450,000**.
  - Organised by a single applicant with at least **ten organisations** from **ten different eligible countries**.

- **Application Deadline:** 5 March 2025, 17:00 (Brussels time).

# KA3

*Provides support to **policy cooperation** at European Union level, contributing to the **implementation of existing policies** and **the development of new policies** <sup>?</sup> **modernisation** and **reforms**, at European Union & Systems' level, in the fields of **education, training youth and sport.***



## Actions implemented through KA3 (I)

Prepare and support the implementation of the EU policy agenda on education, training, youth and sport

Opportunities for **people at any stage of their life** with a **learning experience abroad within their field of expertise**, such as *public governance, agriculture and rural development, new technologies, enterprise etc*

Carry out European policy experimentations

Gather evidence and knowledge about education, training, youth and sport systems and policies at national and European level ☑ facilitate policy making

Contribute to identifying and disseminating good practices as well as success stories from the supported projects in order to give them more visibility and scale them up at local, national and European levels

Gather **evidence and knowledge about education, training, youth and sport systems** and policies at national and European level → facilitate policy making

**Facilitate transparency and recognition of skills and qualifications**, as well as the **transfer of credits**, to foster quality assurance, digital credentialing, support validation of non-formal and informal learning, skills management and guidance.

**Foster policy dialogue** with stakeholders within and outside the European Union, through conferences, events and other activities involving **policy makers, practitioners** and other **stakeholders in the fields of education, training, youth and sport**, to *raise awareness* about *the relevant European policy agendas* and to promote Europe as an excellent study and research destination





# The action supported for 2025 is

## European Youth Together action (by EACEA)

Call ID: **ERASMUS-YOUTH-2025-YOUTH-TOG**

- ✓ targeting both **youth organisations** (*NGOs and public bodies*) at grassroots level and **larger organisations**:

NGOs (including *European Youth NGOs and national Youth Councils*) working in the field of youth; public bodies at local, regional or national level working in the field of youth; for-profit organisations may also participate but not as coordinator.

- ✓ supporting partnerships across borders

**consortium of minimum of 5 applicants** (beneficiaries, not affiliated entities) from at least 5 EU Member States and/or third countries associated to the Programme. *Affiliated entities and associated partners do not count towards the minimum eligibility criteria for the consortium composition.*

**!** *The same organisation can submit only one application as coordinator by the deadline*



## European Youth Together action – activities:

- ✓ Need to contribute to widening the outreach towards young people to ensure a diversity of voices, and reach a diverse range of young people within and beyond youth organisations, including youth with fewer opportunities
  - **development and implementation of the EU Youth Strategy, policy formulation and interaction with major stakeholders in the field of Youth**
- ✓ **Involving a variety of traditional and digital channels** and facilitate the development of partnerships and networks, enabling participation and access for grassroots NGOs and youth movements
- ✓ **Mobility activities for young people** may form a key component of European Youth Together projects



# European Youth Together action – activities:

*Activities must take place in an EU Member State or third country associated to the Programme*

**Duration:** 24 months; extensions – strongly justified are possible

**DDL:** 6 March 2025, 17:00 CET/ Brussels time

**Budget:** Max EU contribution per project - EUR 500 000 (80%) – *lump-sum grant (page 366 – 367 of the E+ Guide 2025)*

*Applications are submitted to the European Education and Culture Executive Agency (EACEA)*

# General considerations and steps (I)

**△ If the actions - managed by the Executive Agency (KA3, Jean Monet) →**

applicants & partners, must register in the [EU Funding & Tenders Portal](#) → **Participant Identification Code (PIC)** - *if your organisation already has one – it is valid for ever 😊*

**△ If the actions - managed by National Agencies**, applicants must if not already done, register through the [Organisation Registration system](#) (Erasmus+ and European Solidarity Corps) and receive an **Organisation ID (OID)** – *once obtained, it is valid for ever 😊*

**!! In both cases, you need: Legal Entity Form & Financial Identification Form !!**

**Were to apply:**

- for the Executive Agency the [EU Funding & Tenders Portal section on Calls for proposals](#)
- for the national agencies: check the national Agencies platforms

- △ Check compliance with eligibility and financial conditions** – for applicants, partners, associated partners, beneficiaries, activities and number of applications
- △ At least 1 horizontal/ European priority and 1 transversal/ national priority**
- △ Make sure you build considering the award criteria/ evaluation map (specific to each call) for each of the project sections**
